### ANNUAL GENERAL MEETING FOR EQUINOR ASA | DIGITAL PARTICIPATION AND ELECTRONIC VOTING

Equinor ASA will hold the annual general meeting on 10 May 2023 at 15:00 CEST with personal and digital attendance. Voting will only be possible electronically via Lumi AGM on smartphone, tablet or pc.

Digital participation via Lumi AGM will give the shareholders the possibility to cast votes on each agenda item, submit questions as well as follow the live webcast which includes simultaneous translation into English.

No pre-registration is needed for digital attendance. However, shareholders must be logged on before the meeting starts. We therefore encourage shareholders to log on in due time, it will be possible to log on one hour before the annual general meeting starts.

Secure identification of shareholders is done by using pin-code and reference number found on the form distributed to the shareholders as an appendix to the notice or on the shareholders account in VPS Investor Services.

Shareholders who do not find their pin-code and reference number for access or have other technical questions are welcome to call DNB Registrars Department on phone + 47 23 26 80 20.

Below is a description of how to attend and vote digitally.

#### HOW TO ACCESS LUMI AGM

##### STEP 1

In order to participate digitally you need to access Lumi AGM.

Go to the Lumi AGM website <https://dnb.lumiagm.com> on your smartphone, tablet or pc. You should have the latest browser version on your device.

##### STEP 2

Once you have entered <https://dnb.lumiagm.com> into your web browser, you must enter the following meeting ID: 114-688-536

##### STEP 3

Log in by entering your pin-code and reference number from the form attached to the notice or your VPS-account.

When successfully authenticated, the info screen will be displayed. Here you can view company information, cast votes on each agenda item and submit questions, as well as follow the live webcast.

#### HOW TO RECEIVE YOUR PIN CODE AND REFERENCE NUMBER

All shareholders registered in VPS are assigned their own pin-code and reference number for use at the annual general meeting.

Log on to VPS Investor Services through [www.vps.no](http://www.vps.no) or internet bank, select Corporate Actions, General Meeting, click on the ISIN and you will find your pin-code and reference number (Ref.nr.).

Shareholders who have not selected electronic reception in VPS Investor Services will receive their pin-code and reference number by post together with the notice of the annual general meeting.



#### HOW TO VOTE

When the annual general meeting starts, the items will be open for voting in Lumi AGM.

By clicking on the polling icon you will access the resolutions and voting choices will be displayed.

To vote, select your choice on the screen. A confirmation message will appear to show that your vote has been received.

To change your vote, select another voting direction. You can also choose to cancel your vote. Your last choice before the voting is closed will be final.

Shareholders that have voted in advance or given a proxy, with or without voting instructions, who wish to attend digitally via Lumi AGM, will not receive cases for voting, but still have the possibility to submit questions in Lumi AGM.



#### QUESTIONS

If you wish to submit a question to cases in Lumi AGM, choose the message icon.

Type your message within the chat box and click the send button.

Questions submitted digitally will be moderated before being published to avoid repetition and to remove any inappropriate language.

All shareholders submitting questions will be presented with full name.
